**A RESOLUTION EXPRESSING THE INTENT TO SELL PERSONAL PROPERTY BY  
THE USE OF INTERNET AUCTIONS**

The Lafayette Township Board of Trustees met in organizational session on Monday, January 2, 2012 at 11:30 a.m. at the Lafayette Township Administration building, 6776 Wedgewood Road, Medina, OH 44256 consistent with the notice provisions of the Ohio Revised Code Section 121.22 and the township's public body rule. Members present, Lynda Bowers, Bryon Macron and Nanci Shanley.

Whereas the board of trustees has determined it is in the best interests of the township to sell personal property no longer needed for any public purpose by the use of internet auctions

A motion was made by Trustee Shanley and carried for resolution hereby,

**BE IT RESOLVED** The Board of Trustees of Lafayette Township, Medina County, Ohio hereby expresses its intent to sell personal property, including motor vehicles, road machinery, equipment, tools or supplies which is not needed for public use, is obsolete or unfit for the use for which it was required by Internet auction. Items to be disposed of will be inventoried, listed by department and include the pertinent information (i.e. year, make, mileage or use, etc.) and presented to the Board. The Board will formally vote on the list of items to be disposed of, establish a minimum price for each item, the method of payment and any other terms and conditions of each sale, including requirements for pick-up or delivery. No items shall be transferred to a bidder until such time as guaranteed payment has been received in full.

Township Fiscal Officer, Shirley Bailey, will be the official point of contact for all Internet Auctions. Ms. Bailey may be contacted at 330-725-6515 or by mailing to 6776 Wedgewood Road, Medina, OH 44256.

All property will be available to the public to view on the Lafayette Township website at [www.lafayettetownship.com](http://www.lafayettetownship.com) home page under the title "Internet Auctions" for a minimum of ten (10) days, including Saturdays, Sundays and legal holidays as required in Section 505.10(D) of the Ohio Revised Code.

This Resolution shall be posted on the Lafayette Township internet site: [www.lafayettetownship.com](http://www.lafayettetownship.com) and in a conspicuous place at the Township Administration Office. Notice of this Resolution shall be published once in a newspaper of general circulation in the Township as required by Section 505.10(D).
