RESOLUTION NO. 6-2017

A RESOLUTION AMENDING AND ENACTING THE ZONING CERTIFICATE FEES AND SERVICES SCHEDULE PURSUANT TO SECTION 807 OF THE LAFAYETTE TOWNSHIP ZONING RESOLUTION TO BE EFFECTIVE JANUARY 17, 2017

The Board of Trustees of Lafayette Township, Medina County, Ohio, met in organizational session on the 17th day of January 2017 at the Lafayette Township Hall, 6776 Wedgewood Road, Medina, OH with Trustees Bowers and Costello present.

Trustee Bowers moved the adoption of the following Resolution:

WHEREAS Section 807 of the Lafayette Township Zoning Resolution requires Trustees, by resolution, establish a schedule of fees, charges, expenses and a collection procedure for zoning certificates, amendments, appeals, variances, conditional use permits, site plan approvals, and other matters pertaining to the administration and enforcement of the Resolution requiring investigations, inspections, legal advertising, postage and other expenses, **NOW THEREFORE**

BE IT RESOLVED,

<u>Section 1</u>. SECTION 807 SCHEDULE OF FEES, CHARGES AND EXPENSE is hereby amended and enacted to be effective January 17, 2017 as follows:

H. GENERAL / ADMINISTRATIVE

PROFESSIONAL COSTS – In the event the Zoning Board of Appeals, the Zoning Commission and/or the Lafayette Township Board of trustees find it necessary to obtain any planning, legal, engineering or other expert testimony, all expenses shall be borne by the applicant. If a court stenographer is requested by the applicant or is required, the cost shall be paid by the applicant.

FINANCIAL GUARANTEE – In the even the Zoning Board of Appeals, the Zoning Commission and/or the Lafayette township Board of Trustees find it necessary to require financial guarantee, the Board of Trustees may require a completion bond in an amount up to 10% of the building cost with a minimum of \$1,000 and a maximum of \$10,000.

Penalty fee for failure to obtain any permit prior to construction is double the fee.

Any request for an APPEAL, CONDITIONAL, VARIANCE OR DETERMINATION OF SIMILAR USE shall be accompanied by a minimum non-refundable fee of:
