

Medina County Flag


Formed in 1818, Medina County adopted its own flag in 1990. The county commissioners at the time — John H. Happ, Ralph A. Berry Jr., and Charles E. Hawley — sponsored a flag design contest in cooperation with the Medina County Historical Society, the Medina County Gazette, the Old Phoenix National Bank, and the Medina County School districts.

The winning design was submitted by Calvin A. Ganyard, a lifelong resident of the county. The flag was officially adopted on July 30, 1990.

A 1942 graduate of Medina High School, Ganyard, retired as an administrative assistant in the Medina County Engineer's Department in 1989.

He was motivated to design the flag partly because of his many years as a county employee, and partly because of his family's long, distinguished history. His great-great-grandfather James Ganyard was one of four Ontario, N.Y. residents who purchased Granger Township when it was first drawn on a surveyor's map in 1817.

Fetus Ganyard was one of the township's first three trustees; Milton Ganyard was a Medina County Commissioner in 1880; another Calvin Ganyard was elected to the Ohio House of Representatives in 1892; and Lester Ganyard was the Medina County surveyor from 1894 to 1900, a position that preceded the election of the first county engineer.


